- c) UCF may consider waiving any minor infirmity or non-conformity or irregularity in an EOI which doesn't constitute a material deviation, provided such waiver doesn't prejudice or affect the relative ranking of any Applicant.
- d) The selected Applicant/s will be informed regarding the acceptance of their application(s) and shall be further advised for participation in the EOI process.

15. FEDERATION (UCF)'s Right to amend the Scone of Work.

- a) If for any unforeseen reasons, FEDERATION (UCF) would require to change the Scope of work, this change shall be acceptable to the Applicant without change in the application submitted under this EOL
- b) FEDERATION (UCF) reserves the right to reject one/ all the EOIs or cancel the EOI without assigning any reasons thereof.

16. Corrupt or Fraudulent Practices.

- c) FEDERATION (UCF) may declare an Applicant ineligibly. either indefinitely or for a stated duration, to be awarded or contacted if it at any time determines that the vendor has engaged in corrupt and fraudulent practices during the execution of the contract.

17. Interpretation of the clauses in the EOI Document

In case of any ambiguity/ dispute in the interpretation of" any of the clauses in this EOI Document, FEDERATION (UCF) interpretation of the clause shall be final and binding on all Applicants parties.

SECTION-IV

GENERAL PROVISIONS AND APPLICABLE LAWS

Applicable Law, Jurisdiction, And Dispute Resolution

- a) This EOI documents and award of work/Purchase order under this EOI documents shall be constituted and the legal relationship between the parties hereto shall be determined and governed according to the laws of the Republic of India and only courts at Delhi and High court of Delhi shall have the jurisdiction in all the matters arising out of / touching and/or concerning this agreement and parties to this agreement agree to irrevocably submit to the exclusive jurisdiction of those courts for purpose of any such proceeding. The aforementioned exclusive and irrevocable jurisdiction of the aforesaid court is irrespective of the place of occurrence of any course of action about any dispute between the parties.
- b) All or any dispute arising out or touching upon or about the terms of this EOI documents including the interpretation and validity of the terms thereto and the respective rights and obligations of the parties shall be settled amicably by mutual discussion failing which the same shall be settled through arbitration. The arbitration proceedings shall be governed by the Arbitration and Conciliation Act of 1996 (as amended up to the date) or any statutory amendments/modifications thereof for the time being in the force. The seat & venue of the arbitration shall be in New Delhi, India, and the language of the arbitration shall be English.
- c) There shall be separate legal clauses under the award of work and the same shall be incorporated in Service Level Agreement. Should any extra-ordinary and unforeseen circumstances arise, like fire, flood, or any other natural calamities, strike, riot, civil commotion, epidemic, plague, accident, and/or ware preventing either contracting party from fully or partially carrying out the obligations under the EOI, party so prevented shall inform in writing the other party of the causes of such failure within 3 (three) days from the beginning thereof and shall not be liable for performance of the contract wholly or to the extent of non-performance, as the case may be.

3. HOLIDAY LISTING

Not withstanding anything contained in this EOI documents, FEDERATION (UCF)'s policy for Holiday- Listing of an Agency mutatis mutandis applies to this agreement in event, the agency(s) while discharging its obligations under the Agreement or otherwise, come(s) within the ambit of the said policy, FEDERATION (UCF)'s at its sole discretion reserves the right to suspend/discontinue dealings or take any curative measures with the agency (s) by the policy in force.

4. PREVENTION OF FRAUD AND CORRUPTION

a) The applicant(s) shall be bound to take all measures necessary to prevent Fraud and Corruption while dealing with FEDERATION (UCF). - d) FEDERATION (UCF) reserves the right to call for any additional information/documents right (s) and the same shall be submitted by the Applicant(s) to FEDERATION (UCF) within a given period.
- e) FEDERATION (UCF) reserve the right to cancel this EOI in totality without assigning any reason.
- f) FEDERATION (UCF) reserves the right to increase or decrease the quantity of this EOI without assigning any reason.
